#### We petition the Court for a faculty to authorise the following-

Please describe the works or other proposals for which a faculty is sought in the way recommended by the Diocesan Advisory Committee in its Notification of Advice.

#### SCHEDULE OF WORKS OR PROPOSALS

#### Proposal.

The proposed scheme is to reconstruct the internal doors to the church and thereby providing and improved seal around the door frame, thus preventing draughts and reducing heat loss. At a later date, a replacement of the existing fixed glazing in the porch window wall may be considered and replaced with an opening glazed panel.

Justification.

The upgrade of these doors, which incidentally will contain much of the repurposed existing doors, is considered necessary not just to provide better insulation, but to improve access not only for mobility scooters but also to improve height clearance as the present design is problematical during funerals when coffins are borne aloft. This project is also coincidental with a scheme to remove the pews, replace with stackable chairs , and to repair, resand and reseal the existing parquet floor blocks. This is all considered vital for the continued use of our church building for both religious and secular events. Making it a major hub for community use in the village.

#### **Statement of Significance**

# 1) Section 1. Brief history and description of the church building(s), contents, churchyard and settings

All Saints, Great Saughall is a Grade II listed building of Ruabon brick, first used for worship in 1896 and consecrated in 1901. It was extended a little over a decade later with the addition of a chancel, sanctuary, organ chamber, vestry and spire and was consecrated by the Bishop of Chester in January 1911. In 2000, a large part of the north side was re-ordered to provide a meeting room, kitchen, disabled friendly toilet and an amount of higher level storage space.

The church itself is in generally good condition structurally and as a result of a previous Quinquennial Report most of the emphasis was on the pressing need for re-tiling the roof, the associated cleaning and re-painting of gutters and re-pointing of higher level brickwork. This work (including total roof insulation) was completed in 2012. New main heating boilers were installed in 2010 and a new kitchen boiler in 2011. More recently, black bespoke wrought iron handrails have been installed at the chancel steps, the whole building has been re-wired at a cost of £18,000 and a new sound system was installed . In 2019 a digital screen and sound bar was installed above the pulpit, thus enhancing the quality of service presentation. By 2020 the new kitchen extension and refurbishment, complete with a secondary egress and storage area was also completed.

The graveyard extends to three sides of the building and is still in use. However at the present rate of about 5 burials per annum, it will be only available for another year or two. A Garden of Remembrance has been created and this is available for the internment of cremated remains for the foreseeable future. Existing gravestones have been checked, and where necessary, made safe on a regular basis. Graveyard maintenance is carried out fortnightly in the summer months.

ALL SAINTS, Church Road. 1894-6 by J Medland Taylor and 1909-10 by Isaac Taylor (E end and N aisle). Of hot Ruabon brick, inside and out, with a slight diaper. Medland Taylor crotchets include the circular window of the S transept with Perpendicular tracery (cf. his earlier St Anne, Denton, SE Lanc.), The placing of the E window of the polygonal apse just a little higher than the other windows, and the prolongation of the nave roof over the south porch. The S transept is longer but lower than the N one. The rectangular central tower carries a green-slated spire with very low broaches and little louvered openings, very Douglas-like. The N arcade, now partitioned off, is of brick with no capitals, just blocks of stone flush with the piers. Good furnishings, including the opus sectile REREDOS by Powells. PAINTING on the apse by Herman Saloman. Some good mid-C20 STAINED GLASS including a window on the N by AV Holloway, 1964.

#### 3) Assessment of the impact of the proposals on the significance defined in Section 2

The effect of the proposed works on the interior of the church is expected to be minimal as

- a) The existing doors are being retained and reconstructed to provide a better seal.
- b) The existing porch window is being utilised and reglazed with an opening facility to allow air pressure release in the porch.

No other alterations are in prospect with this scheme.

#### **Statement of Needs**

#### **General information**

Saughall is a small rural village with a population of 3009 at the 2011 census. It lies just over three miles west of Chester at the edge of the Wirral with ready access to the motorway network being near the end of the M56 Motorway and the North Wales Expressway. The village amenities include a General Store and Post Office, Pharmacy, 2 Public Houses and a small range of shops including hairdressers and a takeaway. There are playing fields which are host to Saughall Colts and a soft play area for children. There is also a village hall known as the Vernon Institute.

The current congregation is a predominantly older one with a few younger families attending from time to time. Only a few attendees live outside the parish. Saughall is widely regarded as a 'rural' village parish with a distinct identity

All Saints, Great Saughall is a Grade II listed building built of Ruabon brick, and was first used for worship in 1896 and consecrated in 1901. It was then extended a little over a decade later with the addition of a chancel, sanctuary, organ chamber and spire and was consecrated by the Bishop of Chester in January 1911. In 2000, a large part of the north side was re-ordered to provide a meeting room, kitchen, and a disabled friendly toilet along with some higher level storage space.

The church is generally in good condition structurally and as a result of a previous Quinquennial Report most of the emphasis was on the pressing need for re-tiling the roof, the associated cleaning and repainting of the gutters and re-pointing of high level brickwork. This work (including total roof insulation) was completed in 2012. New main heating boilers were installed in 2010 and a new kitchen boiler in 2011. More recently, bespoke black wrought iron rails have been installed at the chancel steps, and the whole building re-wired at a cost of £18,000 and a new sound system installed.

In 2019 a digital screen and sound bar was installed above the pulpit, enhancing both audio quality and service presentation. By 2020 a kitchen extension and refurbishment, complete with a secondary egress and storage area was completed.

At 2.15pm on Wednesdays there is a 'Cuppa and Play 'service for pre—school children and their carers. Once a month, on a Friday at 3.30pm; 'Kids Ark 'provides worship and activities for primary school children and their parents.

There are regular joint services with the other two local churches and a monthly family service on each third Sunday at 9.30am.there is also a fortnightly communion held at 10.30am on Wednesday morning. Special services include the festivals of Christmas, Easter, Mothering Sunday and Harvest.

The nearby Saughall All Saints Primary school hold services in church at least once a term.

There is a monthly 'Soup and a Pud' event held in the meeting room every second Monday in the month giving villagers a great opportunity to meet, relax and chat over some home produced fare.

The 'Prayer Circle' is a group of like minded local people from the three local churches committed to responding to any particular prayer request from anyone within our community or beyond.

#### What is needed?

The scheme includes the reconstruction of the internal doors between the porch and the main body of the church plus the fitting of a reglazed opener window in the south wall of the porch

#### The proposal

The main object of the scheme is to reconstruct the internal doors to church to provide a good seal all round, and to prevent draughts and hence heat loss in church. Associated with this, to permit release of possible pressure in the porch, will be the replacement of the fixed glazing in the existing window with an opening glazed panel.

#### Justification

Heat retention in church with consequent saving on fuel bills.
