## ANNUAL REPORT FOR THE YEAR ENDED 31<sup>st</sup> DECEMBER 2018 AIM AND PURPOSES

St John the Evangelist Parochial Church Council (PCC) has the responsibility of cooperating with the Incumbent/Priest-in-Charge, in promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical.

The PCC is also specifically responsible for the maintenance of the church complex of St John the Evangelist Macclesfield.

#### **Objectives and activities**

The PCC is committed to enabling as many people as possible to worship at our church and to become part of our parish community at St John's. The PCC maintains an overview of worship throughout the parish and make suggestions on how our services can involve the many groups that live within our parish. Our services and worship puts faith into practice through prayer and scripture, music and sacrament.

When planning our activities of the year, the ministers and the PCC have considered the Charity Commission's guidance on public benefit and, in particular, the specific guidance on charities for the advancement of religion. We try to enable ordinary people to live out their faith as part of our parish community through:

Worship and prayer, learning about the gospel and developing their knowledge and trust in Jesus,

Provision of pastoral care for people living in the parish,

Missionary and outreach work.

To facilitate this work it is important that we maintain the fabric of the church of St John the Evangelist and of the Church Centre.

#### Structure, governance and management

The Parochial Church Council is responsible for making decisions on all matters of general concern and importance to the parish including deciding on how the funds of the parish are to be spent. The method of appointment of members to the church council is set out in the Church Representation Rules. The membership of the church council consists of the incumbent, the churchwardens, nine elected members and the two Deanery Synod representatives who are ex officio members of the church council. The electorate comprises the members on the church electoral roll so it is important that that is an accurate reflection of those who attend services or are members of the congregation in some other way. It currently stands at 54 members.

The PCC has met on five occasions over the calendar year.

The Council is supported in its work by a standing committee. This committee normally comprises the churchwardens, the treasurer, the secretary of the Council and one other member nominated by the council along with the Incumbent. To assist in communication between clergy and laity the standing committee was re-constituted in 2017. Agendae have been compiled by the PCC minutes secretary in conjunction with the incumbent and standing committee.

The parish of St John the Evangelist is situated on the west side of Macclesfield and includes within its boundaries a large estate of housing association houses, much of which is now privately owned along with other areas of private housing including an area of significant executive type properties. The parish is part of the Diocese of Chester within the Church of England. It is a member parish of the Macclesfield Deanery Synod. The church council is a separate legal entity known as a body corporate and is currently a charity excepted from registration with the Charity Commission.

#### Achievements and performance

#### Worship and Prayer

The PCC is keen to offer a range of services that our community will find both beneficial and spiritually fulfilling. The Family Service held on the second Sunday of the month provides a more relaxed and informal style of worship. It is not specifically aimed at children but the degree of interactivity between leaders and congregation is intended to make this service a more fulfilling experience for the younger person. On other Sundays of the month Sunday Club meets at the same time as the morning service and the children join the rest of the congregation for the sharing of bread and wine. The congregation is always pleased to hear what the children have been up to!

Mid-week services are currently held at Wykeham Chase and Park Mount. Services are held on certain Feast and other Holy Days.

For the time being the principal service on the fifth Sunday of the month is united with St Thomas's and held alternately at each of the parishes, subject to any overriding requirements of any particular Sunday or the parishes.

Subject to the above, our main act of worship continues to be the Family Communion Service held on the other Sundays of each month. We are extremely grateful to Crawford Scholes for his skilled services on the keyboard two Sundays a month. Other Sundays are dependent on hymns played electronically, with varying degrees of merit.

The monthly prayer breakfast continues to meet on the first Saturday of each month. Whilst supported by only a small core it is an important time for fellowship, reflection and prayer. There is no obligation to pray out loud. An individual's prayer is often followed by a period of silent reflection.

The Messy Church team continues to support an event every couple of months on a Saturday afternoon. Themes are based on seasons of the Church's years such as Pentecost, Harvest Advent and Easter and well-loved Bible stories. The attendance has ranged from 9 to 35 children plus accompanying parents or grandparents.

As well as our regular services, we welcome and celebrate with families the baptism of children and we share the grief and give thanks for the lives of many people through funeral services held either at the church or the crematorium. We have celebrated 12 Baptisms, 1 wedding and shared the sadness of 11 families by way of funerals in 2018.

#### **Deanery Synod**

The parish is entitled to two members of Deanery Synod along with the incumbent. This provides the PCC with an important link between the parish and the wider structures of the church. Deanery Synod members are ex officio members of the PCC. Regretfully Synod has only met a couple of times in



2018. From time to time the PCC is invited to discuss issues which are being debated in the national church and thence the Diocesan and Deanery Synods.

#### **The Church Centre**

The church forms part of a centre which is used by and is available to the whole of our community for a wide variety of meetings and social events. A significant part of our income is raised through room hire fees, without which the PCC could not meet its financial obligations. The warm welcome which is given to the users of the Centre is much appreciated by them but it is incumbent upon the PCC to maintain the rooms in a good state of repair and heat them adequately. A list of users in 2018 is set out in Appendix I.

#### Mission and Evangelism

It is the policy of the church council to distribute to charities for church mission or secular purposes at home and abroad 5% of the giving to the church received through standing orders, the envelope scheme or the open plate. In 2018 the charities chosen in 2016 received the last of three annual donations. The policy of two overseas and two home-based charities was maintained and the concern for refugees expressed previously had been taken on board. 2018 saw gifts of £194.96 to each of The Salvation Army in Manchester, Cre8, the Barnabas Fund and The Foundation for Relief and Reconciliation in the Middle East. It is policy to support organisations for up to three years. The council is always pleased to receive suggestions from members of the congregation as to where this giving can be directed.

#### **Ecumenical Relationships**

The church has for many years been a member of Churches Together in Macclesfield. This organisation was superseded in 2010 by the establishment of a new ecumenical relationship of 29 churches which goes by the name of Hope in North East Cheshire. (It remains affiliated to Churches Together.) We make an occasional financial contribution as requested to enable mission across a broad range of activities A voluntary donation of £100 was made in 2018.

Our joint services with our neighbours at Broken Cross Methodist Church, Calvary Church and the Anglican churches in Henbury and Upton Priory have continued but on a less frequent basis. All churches except one close their doors and we meet to worship God in accordance with the practice and style of the host parish. A pulpit swap has also been re-instigated on ?????????

#### Volunteers

We would like to thank all the volunteers who work so hard to make our church community what it is. We give particular thanks to the churchwardens for their service and the responsibility which they undertake. We give thanks for the work of Mrs Bentley in the parish office on Friday mornings especially with regard to the coordination of the lettings; the income from which is so



important. We are grateful for Crawford Scholes' music ministry expanding our repertoire. Finally thanks to Lawrence Robinson as general factotum

#### **Financial Review**

Total receipts were £35,213.81 which included restricted income of £774.89. The donations of flowers in kind by those arranging them is appreciated. Until recently the only restricted fund which has been reported upon is the Curate Fund. There are a number of legacy funds, the income from which in past years has been included in the general accounts as the purpose of these funds is unknown. These legacy funds are endowment funds in respect of which the parish has no access to the capital without charity commission approval. It is also not known whether these are specifically PCC funds or are under the auspices of the Vicar and Churchwardens and therefore not part of the PCC accounts. Their values have not been included as part of the balances shown in the accounts but for the sake of transparency they are now included as part of the funds brought forward. The investments are held by the CCLA on behalf of the parish and the PCC has no control over their management. Details of the individual funds are given in the financial statements which have this year been revalued to reflect current valuations.

Planned giving has remained relatively static for both Gift Aid and non-Gift Aid giving. Members of the congregation are encouraged to sign up for Gift Aid if their income tax position warrants it. To some extent with the new Gift Aid Small Donations Scheme we can claim tax back on all small cash donations of £20 or less so the Church does not lose out entirely! It has been possible to recover some tax on the previous year's giving.

Our fundraising income is very dependent on the generosity of the Parents' Association at St John's School, which has continued despite the Christmas Fair not being the usual financial success of previous years. The PCC decided in 2016 that the Plant Sale should continue in honour of all that the late Ann Gillett had done in respect of this fund-raiser. The more targeted leafleting of addresses away from the church was repeated. Sales were a little lower than the previous years which is also reflected in lower costs, but some expenses are not dependent on the volume of sales and cannot be reduced further.

The greatest single element of expenditure relates to the Diocesan assessed Parish Share, which in 2018 was £29,118 and to which the Parish made a contribution of £18,000. Although our obligation to the Diocese has reduced by more than 50% in the last of couple of years following the uniting of the two benefices the PCC and a further 5% following a re-banding of the parish the the congregation is still unable to meet our financial commitment in full. The PCC made a decision that reserves should not be depleted further and the contribution to the diocese was reduced accordingly. The PCC has continued to make payment of the reduced the monthly contribution to  $\pounds$ 1,500 which is some £927 per month less than is asked of us by the Diocese.



The year saw again some significant expenditure on repairs and renewals. A kitchenwindow has been replaced and a new radio microphone and receiver had to be purchased along with repairs to the lift and the lightning conductors.

There have been no capital items of expenditure.

The net result for the year in the accounts shows a very small surplus on cash basis. Free reserves stand at some  $\pounds$ 8,268 below which it really should not fall. The Curate's Fund cash balance stands at some £12,937 which is restricted to that purpose.

The accounts in the format preferred by the Charity Commission are set out in Appendix III.

#### **Reserves Policy**

The PCC has determined that free cash reserves should not be allowed to reduce below the present level and hence a balanced budget was set for 2018 and will be so for 2019 as far as possible. This balance depends on pledged income being received and the usual level of fund raising. The amount of tax recovered from the Revenue on Gift Aid donations has now fallen to 25p in the pound but still adds a significant sum to individual donations.

#### **Parochial Church Council**

The PCC met on five occasions in 2018 . Financially, the PCC has re-iterated its commitment to a balanced budget. In the absence of any significant increase in congregational giving. The PCC decided that the monthly contribution to the Diocese should be maintained at £1,500 per month. To meet our obligation fully an additional monthly income of £927 is required. The savings in the utility bills are beginning to be seen but the heating is very dependent on the outside temperatures! The finance section of this report contains more details of the parish's financial position.

The beginning of the year saw the vicar's sabbatical for three months. Services were supported by a number of retired clergy to whom thanks are given for all their support and mostly without fee. The churchwardens are thanked for their undertaking the additional burden this placed on them. The greatest problem was when one of the volunteer clergy had lost his voice so the service and his sermon was read on his behalf.

# Messy Church

We have held four very successful Messy Church sessions this year and been joined by lots of families from the church, school and local community. We meet between 3.30pm and 5.30pm on a Saturday afternoon and start with an hour of crafts and activities, followed by games, worship and a tasty meal.

Our Easter session in March took the theme "God's Love" - the children enjoyed making cards, a star mobile, painted hearts, cup cakes decorated with crosses and the challenge of various puzzles. In the Summer our theme was "God's Family" with activities including a Noah jigsaw, Joseph's colourful coat picture, Moses basket weaving, Jonah and the whale clay figures and peg figures of Sarah and Abraham. Saying Thank you to God for all good things was the theme of our Harvest celebration in October - the children made thank you cards, friendship bracelets, animal biscuits and loaves and fishes pictures. Our final session of the year was the Christmas Messy Church Light Party with candle cup cakes, paper lanterns, "let there be light" pictures, a light box and torch activity and shiny Christmas tree decorations.

All ages are welcome - we have soft play and games for the very youngest children and refreshments available throughout the session for the parents and grandparents to help themselves. As always, we are very grateful to everyone who has helped throughout the year with setting up, registration, preparing and assisting with crafts and activities, buying and making food and clearing up the inevitable mess afterwards.

### St John's School

Last year was, once again, an extremely busy year at St John's. We explored many exciting areas of the curriculum, from 'Paw Prints' to 'Rise of the Robots'. We welcomed many visitors into our school and had the opportunity to find out about the things that puzzled us in the world around us.

In April 2018, we were visited by a team of Ofsted Inspectors led by Mrs Maggie Parker. The two day inspection was a rigorous process during which inspectors observed lessons, interviewed the pupils, teachers, parents and governors and looked in great detail at children's work. We are all hugely proud of the overall 'Good' judgement and were delighted that the inspectors recognised the hard work that had been put in by everyone since the last inspection in 2014. We enjoyed a guided walk by the River Bollin – where we held leeches, chewed grasses that taste of biscuits, met the Bollin Valley cattle and skimmed a few stones. We were also lucky enough to have a session run by the coach from Lancashire Thunder (the women's cricket team) as well as some outdoor cooking activities and team sports.

During the Autumn Term we concentrated on the Plastic Free Planet badge which involved lots of activities to learn about plastic pollution and ways we can help change habits. The girls decorated "bags-for-life" and made reusable kitchen food wraps with fabric and beeswax.



We have, as always, enjoyed several residential opportunities in 2018. We had an amazing weekend of watersports in the Midlands during the first roasting hot weekend of the year in May. Our week-long Summer Camp was in the Cotswolds this year and the theme was all about Farming in the UK. We were lucky enough to have an exclusive behind the scenes tour at Daylesford Organic Farm, and nibble on some the award-winning cheeses, straight from the dairy. The week culminated in a "village show" with competitions for the best jam, scones, flower arrangement and vegetable monster!

We are delighted that our Guide unit continues to thrive at St John's School, our numbers are currently very healthy and we're looking forward to more adventures in 2019.

#### St John's Senior Section

Our Senior Section group (girls are aged 14 - 18) continues to meet twice a month in the Church Rooms. Many of our members are Young Leaders with Rainbow and Brownie units in the local area and the girls are really enjoying this opportunity to give something back to Guiding. Many of the girls are also taking part in the Duke of Edinburgh scheme and are well on their way to achieving various levels of this award.

The new Girlguiding program was launched in the summer of 2018 so this year the Senior Section group's activities have included some from the old program as well as trying out some from the new one. The girls value the opportunity to meet with friends and take part in a variety of activities.

Some activities have been quite serious, such as sharing revision tips and techniques, creating journals to help begin to know yourself and marking the centenary of the women gaining the right to vote. Others have just been fun, such as celebrating International Carrot Day with carrot themed quizzes and a carrot carving competition. We also really enjoyed an evening with two members of the local Aikido club, who came to teach some self-defence moves to the girls. They found this really helpful and quite good fun – throwing the instructors and each other onto the floor!

Several Senior Section members joined our Summer Camp this year as Young Leaders. They worked really hard, learned a lot and became valuable members of the Leadership Team. We'll be looking forward to welcoming them to help at Summer Camp 2019.



We're excited to be working with this group of girls who have so much enthusiasm for Guiding and are taking a really active part in their local communities and further afield.

#### Vicar's Report

#### Notes to the accounts

- 1. The financial statements have been prepared on the prepayments and accruals basis in accordance with the Church Accounting Regulations 2006. The use of prepayments and accruals for a parish with a turnover of approximately £50,000 p.a. is optional but follows the convention of the parish.
- 2. The activities for funds generated include not only fundraising such as the Plant Sale and Fairs but also the rental income from users of the halls and rooms. The hall fees amounted to some £8936 and although much reduced remain a crucial element of the parish's income.
- 3. The endowment funds referred to in the Financial Review are represented by the following funds and they may or may not be part of the PCC's financial responsibility depending on the exact wording of the original gift to the parish. The details are lost in the annals of time. They are shown here for the sake of fullness of information and have been revalued to current values.
