Thank you in anticipation, for reading this address. I hope you will consider **allocating me a 'high priority' vote**

The ongoing world crises have exposed our shared vulnerabilities and *'neglect of what nourishes and strengthens the life of the community ... and how we have failed to pay attention to the suffering all around us'*. It has also shown us how we are capable of acting in adversity (Pope Francis). Opportunities to use new forms of communication have emerged, and online church services have created new ways of providing spiritual care to a sizeable group of people, some of whom would not or could not normally attend church services.

The time is ripe to build a better society and a greater sense of community, and it is therefore an exciting and challenging time to be elected to serve in the House of Laity of General Synod.

If elected I hope to work with other members from Chester diocese to ensure that parishioners are made more aware of the current work of the Synod.

As someone who was confirmed relatively recently and is quite new to church politics, I believe I can represent the views of the 'average person in the pew'. I also retain something of an outsider's perspective, and can thus readily associate with the feelings of people who have not yet felt God's love, as we work to bring about a church which is welcoming, inclusive and plays a leading role in addressing the challenges which currently face the church and society.

Careful deliberations need to continue, since pastoral re-organisation and strategic developments may potentially lead to further irreversible church closures and stipendiary clergy redundancies.

**God stands with the oppressed**

The church needs to respond to the social injustice and discrimination experienced by marginalised groups

Notions of inclusion and social justice should radiate from parishes and be reflected back

Inter-faith and inter-denominational efforts towards world peace should be redoubled, with urgent efforts made by churches to provide for the needs of refugees from Afghanistan and elsewhere

Efforts must be made to rebuild public trust following publication of the findings of IICSA and the forthcoming Smyth Review. These should include rigorous processes of institutional self-examination and the fullest possible restitution to victims

Lord Boateng (new Chair of the recently launched Archbishops’ Racial Justice Commission) said: “Racism is a gaping wound in the body of Christ’s church. Our mandate as a Commission is not only to bind but to heal.” General Synod will in due course be involved in addressing its recommendations
