NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Renewal of the bell frame, involving the removal and disposal of the existing frame, transporting of the bells and fittings to the workshop for works of maintenance, cleaning and repair, replacement of the frame in galvanised steel, and reinstatement of the frame, bells and fittings to the tower

Removal and disposal of heating system items in the tower, comprising all the burner and control gear, plus gas pipework and ducting

Removal of most of the radiators from the church apart from four large Victorian radiators at the cross aisle towards the west end where they will be visible from the entrance of the church

All in accordance with:

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
