NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

1. Replacement of the churchyard pathway from the south porch to the main gate with a new continuous path that has a resin bound surface and stone edging. The ledgers forming the existing pathway to be placed in safe storage.
2. Creation of a well-defined circular area just outside the south porch forming a gathering area. A black granite memorial stone to be inset at the centre of this circular area, in memory of the late Rev Dr Richard L Hills, MBE
3. Installation of four low level lighting bollards along the length of the path, controlled by a PIR sensor above the porch door and with cabling in a duct below the path terminating in two waterproof junction boxes, one on each gate pillar. A floodlight to be added above the porch door.
4. Introduction of a wooden bench on a concrete base positioned halfway long the path
5. Replacement of a band of cobbles between the churchyard gates and Warhill just outside the churchyard with tarmac. The removed cobble stones to be used to form edging for the new path in the churchyard

3. Drawing Proposed Path Improvement Scheme Revision D dated May 2022
4. Cross section drawing showing path construction method, uploaded 23 May 2022

7. Additional detail re the new floodlight attached to email of Tony Kershaw dated 5 August 2022

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
