NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Refurbishment of the Church Hall comprising:

- Clearing of shrubs and undergrowth to allow access.
- Stripping out of the building to remove redundant fixtures, fittings and equipment including heating and electrical installations that are no longer functional
- Replacement of wall panels (and include double glazing and white UPVc door sets) and window frames and repair/replacement of upright timber posts. Insulation of the gable walls. Fitting of timber skirtings to all walls.
- Provision of timber cladding and white UPVc T&G fascia board system to complete the perimeter of the roof.
- Reroofing with suitable high performance built-up/ multilayer roofing system and including insulation. Replacement of all gutters and downpipes in UPVc.
- Provision of new gas-fired central heating system for the hall also providing domestic hot water to the existing kitchen
- Provision of new electrical installations. Installation of low energy, zoned LED lighting. Installation of intruder alarm system and intercom and access control/door release system
- Installation of low energy external security lighting to the car park area adjacent to the hall and the small courtyard at the entrance to the hall and church. Installation of CCTV camera to cover the area of the front door
- Filling/making good of any uneven areas of the floor and repainting of the whole floor. Repainting of the handrail to the steps from the escape door at the east end of the hall
- Laying of a flag wide footpath around the rear perimeter of the building for future access and maintenance

### Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
