NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Installation of audio-visual equipment including:

• retractible screen suspended behind the chancel arch

• projector and recording microphone mounted just below the lights to the arched junction of the nave and south transept.

• camera for live streaming mounted on the central pillar between the west end windows, utilising previously drilled holes that had since been filled.

• six speakers to replace the existing four speakers, with one of the existing speakers being relocated to the porch. The new speakers to be located one at each side of the nave, one under an overhang under the organ pipes, two on the pillar by the pulpit facing front and back, and one in the organ loft

• Introduction of new mixing desk and associated controls including monitor, with oak desk/table with tambour cover, and oak partition, to replace the existing mixing desk in the same location at the south side of the nave towards the west end

Removal of the rear two rows of pews from southside of the nave to make space for the new mixing desk cabinet

Removal of the rear two rows of pews from the north side of the nave

Removal of the spare pew positioned along the north wall at the west end and the spare pew and frontal positioned along the south wall of the north chapel. The pew frontal to be adapted and re-used for the partition next to the mixing desk.

Directions to petitioner
